

3. Quoted rate must be inclusive of GST and applicable charges. Quotation must have proper mailing address, email ID and contact number and supported with GST registration certificate and PAN card of the firm/individual. **Quotations not as per the requisition will be rejected without any intimation.**
4. Quotation in sealed envelope title as "**Supply and Installation of CCTV in old hostel**" to be dropped in the quotation box kept in the office of AIN, Guwahati, C/O 151 Base Hospital, Basistha Temple Road, Guwahati-781029 by latest on **17 Apr 2025 before 11.00 hours**.
5. The warranty of the CCTV and related equipment must be applicable as per the existing policy of the company in vogue. Further the supplier must ensure after sale services, technical support etc. free of cost for the warranty period as given by the company (min 06 month).
6. The stores found defective or not in accordance with the specification mentioned in the work order will be rejected. It will be the responsibility of the supplier to collect the rejected stores and replace the same.
7. Payment will be made through the local cheque by this Institute on submission of the bills subject to the completion and acceptance of the work by the Board of officer detailed by the Institute.
