3. Site inspection/ visit can be carried out to assess the requirement on all working days between 11.00 AM and 1.00 PM. The AIN Hostel "Sampriti building near Panjabari TCP Gate is located inside Narangi Army Area (HQ 51 Sub Area). Entry point is from Satgaon Military Gate.
4. Quoted rate must be inclusive of GST and applicable charges. Quotation must have proper mailing address, email ID and contact number and supported with GST registration certificate and PAN card of the firm/individual. **Quotations not as per the requisition will be rejected without any intimation.**
5. The warranty for the equipment must be applicable as per the existing policy of the company in vogue. Further the supplier must ensure after sale services, technical support etc. free of cost for the warranty period as given by the company (min 06 month).
